Leonard Peltier is a member of the American Indian Movement (AIM), which promotes Native American rights. In 1975, two FBI agents were killed during a confrontation involving AIM members. Peltier was convicted of their murders but has always denied killing the agents. There are serious concerns about the fairness of proceedings leading to his trial and conviction, including for example the prosecution's withholding of evidence that might have assisted Peltier's defence. In light of these concerns, the former US Attorney who supervised the prosecution team post-trial, James Reynolds, has since called for clemency.

Leonard Peltier is now 76 years old, has spent more than 44 years in prison, and has been repeatedly denied parole. There are serious concerns about his deteriorating health. His lawyers have recently submitted a new petition for clemency.

I urge you to grant Leonard Peltier clemency on humanitarian grounds and as a matter of justice.
